## Rules and Regulation for Use of Alloway Township Boat Ramp

1. All users must comply with all State of New Jersey laws governing this facility, the lake and all adjoining properties.
2. All users must comply with the Alloway Township Rules and Regulations governing this facility, the lake and all adjoining properties.
3. Facility is open daily from sunrise to sunset.
4. Either Annual or Daily-Use permits must be purchased to use this facility.
5. The Annual Permit runs from January 1<sup>st</sup> to December 31<sup>st</sup> of the current year.
6. Permits will not be pro-rated.
7. Permit decal must be displayed in a visible location on the **back of the rearview mirror** of the vehicle used to tow the trailer.
8. Vehicles with boat trailers must park in the designated area.
9. Boats must be no longer than 18 feet in length.
10. **In accordance with laws of the State of New Jersey, only battery-powered electric motors may be used on boats operated in Alloway Lake.**
11. All owners will be held fully responsible for any damage caused to property, private or public, by their boats and vehicles under anyone operation.
12. All discarded trash, litter, bottles, fishing materials, paper and boxes shall be placed in the correct trash receptacles located at the facility.
13. Permit fee for Non-Township Resident is \$100.00 per year. Day Use Fee is \$10.00.
14. There is a 10% discount for military veterans on the annual pass. Veterans must submit a photocopy proof of service along with their application in order to receive the discount.  
There is no discount on the daily passes.

**The Township of Alloway reserves the right to revoke or suspend without compensation any permit issued by them as a result of failure to obey with any of the above laws or for other cause.**
