

At 5:04 p.m. the Regular Meeting of the Alloway Township Finance Committee was called to order by P. Ed McKelvey, Mayor. The meeting was advertised in the South Jersey Times and the Elmer Times in accordance with Public Law 1975, Chapter 231.

The flag salute was led by Mayor McKelvey

Roll Call - Present: Morgan, Patrick, McKelvey

Municipal CMFO/QPA, Bette Jo Pigliacelli and Township Treasurer, Lois Yarrington was also in attendance. Due to illness Clerk Charlet Cheeseman was absent.

### PUBLIC SESSION

On motion by Patrick, seconded by Morgan, the public session was opened and Mayor McKelvey called for any questions or comments from the public.

Vote: All in favor

Fire Company Representatives, John Mahala and Chris Hagan attended the meeting. Discussion took place regarding the following: fire company taking ownership of the building; fire company donations and their expenses; township contributions; fire trucks are 30 plus years old; applied for grant for turnout gear etc. The representatives stated they want to be employees of the Township and explained what the funds go towards. They are requesting the Township to increase their contribution amount another \$19,000 to be brought up to \$44,500 in contributions, not including the building/maintenance etc. expenses that the Township handles. They informed the Committee that 5 people in FF1 (officers) this year and are to be commended. The Township Committee agreed they will see if it is possible for the Township to increase their contribution amount by \$10,000.

There being no further comments from the public, a motion was made by Patrick and seconded by Morgan to close Public Session.

The Township Committee members reviewed the bill list and with no one having any questions, the approval sheet for the Bill List was signed.

The following was discussed:

- TRICO-JIF Dividend in the Amount of \$8,954: Discussion ensued and the Committee agreed that it gets applied towards 2022 Assessment.
- American Recycling Proposal (ARA): CPWM Micklasavage contacted this company. It is \$1 less than Township paid SCIA to take the white goods and this company will pick up and take them.
- Dental Plan--Is it employee only or employee plus dependents: Discussion ensued and the Committee agreed that it will be same as the health insurance...which allows dependent(s) on policy.
- Disability & Contribution to Healthcare Plan when out on disability: Discussion ensued and the Committee agreed that the Township will pay the employees cost when out on disability.
- Cleaning Services for Municipal Bldg: Discussion ensued and it was the consensus of the Committee to get quotes for cleaning services 2x/ month; auditorium 1x/month
- As needed Snow Plow Driver: Previous individual not available
- Sewer Utility: No increase
- Steps at recycling area at Convenience Center: Can use Recycling Tonnage Grant Funds to fix

The Committee members had no revisions to November's regular meeting minutes or September's Board of Health Minutes meeting minutes.

Lastly, the Committee reviewed the 2022 contracts that were submitted. Discussion ensued. The 2022 Standing Committee Structure List remains the same after discussion took place. Reappointments for members of Agriculture Advisory, Environmental Commission, Board of Recreation, Planning Board and Steering Committee were discussed. Mayor McKelvey stated if a member doesn't make meetings, they need to resign or start to come to the meetings.

Committee Morgan spoke about the situation in Paradise Lakes and the road not fixed. The Code Official did contact the DEP regarding the property and is being handled. He also stated that the 7 puppies at 461 Alloway Friesburg Road have been licensed.

There being no further business to come before the Committee, on motion by Patrick, seconded by Morgan, the meeting was adjourned at 6:43 PM.
