

At 5:05 p.m. the Regular Meeting of the Alloway Township Finance Committee was called to order by P. Ed McKelvey, Mayor. The meeting was advertised in the designated newspapers in accordance with Public Law 1975, Chapter 231.

The flag salute was led by Mayor McKelvey.

Roll Call - Present: Morgan, Patrick, McKelvey

Also in attendance was Municipal Clerk Cheeseman and CFO Pigliacelli

On motion by Patrick, seconded by Morgan, the public session was opened and Mayor McKelvey called for any questions or comments from the public.

Vote: All in favor

James Bambrick has a lot on Lakeview Drive. He inquired about getting Lakeview Drive connected to the sewer line. Mayor McKelvey explained at the time of the initial installation of the sewer system, the cost would be far too expensive to run up to Lakeview Drive. He shared the Township has a vac sewer system not a gravity system. The Committee agreed they would need to obtain more information.

John Mahala, Alloway Twp. Fire Chief informed the Committee of the following:

- County Dept. of Health: Inspection of kitchen at the Fire House went well... nothing major to report
- Fire House: No hot water... Mayor will instruct DPW to visit the firehouse
- Rain Garden: Weather permitting, installation will begin Monday, 9-19-2022

There being no further comments from the public, a motion was made by Patrick and seconded by Morgan to close Public Session.

Vote: All in favor

The Township Committee members reviewed the Bill List. There were no questions and the approval sheet for the Bill List was signed.

The following was discussed:

1. Revised proposals for surveillance system for municipal building: It was the consensus of the Committee to award the contract to AV Communication Systems.
2. Printers of Salem County: Quote received for boat ramp envelopes approved by the BRC and Twp. Committee.
3. Diesel Oil Company: After brief discussion, changing companies was approved by the Township Committee.
4. "New" Lead-Based Paint Law: Twp. Solicitor is preparing an Ordinance for Alloway Township to adopt.
5. Notification from NJDEP: NJDEP contacted the Twp. Solicitor acknowledging the Townships request to Appeal the Reassignment of Stormwater Permit from a Tier B to a Tier A.
6. 2022/2023 County Co-Op Agreement for Rock Salt: Township Clerk was informed by current company that they did not renew agreement with the County.
7. TRICO JIF Insurance: Discussion ensued.
8. SJL&WT MOU Agreement signed by Mayor McKelvey and Fire Chief Mahala for installation of a rain garden on property at ATFC.

CORRESPONDENCE/DISCUSSION:

1. Notification from County DOH: Illegal food vendors operating in Alloway
2. Notification from County Engineer: Municipalities no longer need to participate in Storm Water Booth at County Fair
3. Resignation letter received: Discussion ensued

Mayor McKelvey shared that Quinton Mayor, Marjorie Sperry, approached him asking if Alloway would be interested in shared services with Quinton for use of the Alloway Convenience Center. Discussion ensued. The Committee agreed they don't think this would be good for Alloway.

The Committee members had no revisions for the August meeting minutes or June's Board of Health meeting minutes. The Committee reviewed the upcoming items on the agenda and agreed to support Salem City as the home of a Wind Institute. Mayor McKelvey instructed Clerk Cheeseman to prepare a resolution for the upcoming meeting agenda.

Committeeman Morgan provided information regarding the sale of the Hardware Store. Discussion ensued and Committeeman Morgan will contact the Planning Board Chairman for direction.

Mayor McKelvey reported that he attended the County Public Works meeting and hopes that the County Board of County Commissioners will agree to install 4-way stop signs at the main intersection in Alloway Village.

Deputy Mayor Patrick shared he is in the process of talking with the BRC and the Steering Committee regarding the possibility of dissolving those committees.

There being no further business to come before the Committee, on motion by Patrick, seconded by Morgan, the meeting was adjourned at 5:55 p.m.
