Pump Station – discussion regarding if this was a land purchase or an easement by the Township, as it was suggested by the Township Solicitor, Jacci Vigilante, to Clerk Cheeseman that an easement would be easier, so as to avoid having a Planning Board Hearing. Per the initial discussions regarding the Pump Station Deputy Mayor Leady negotiated for the sale of the land not for an easement. Committee agrees that this should be done as a purchase, not as an easement. Clerk Vanaman to clarify this with the Solicitor, and Planning Board Professionals and move forward as such.
